SHARE INSURANCE COVERAGE

Not one penny of insured savings has ever been lost by a member of a federally insured credit union.

The standard maximum deposit insurance amount is \$250,000 per depositor for each account.

Deposits maintained in different categories of ownership at the same credit union can be separately insured, making it possible to have shares of more than \$250,000 at one credit union and still be fully insured.

Retirement account deposits are insured by NCUA separately up to \$250,000.

The CU will NEVER send you an email asking to verify personal information.

Report lost or stolen debit and credit cards immediately. Call 800-500-1044

Accounts are federally insured up to \$250,000 by NCUA.

You are entitled to one free credit report from each of the three nationwide credit bureaus every year. To get your free report, go to www.annualcreditreport.com or call 1-877-322-8228.
